

Welcome to the CMSS Annual Meeting 2024!

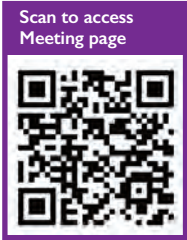

Session Descriptions

Protecting Patient Health in a Changing Climate: A New Imperative for Medical Leadership

In this opening plenary session, Dr. Mary Rice will share her expertise and research on the impact of climate on health and help us explore the role of specialty societies in developing evidence-based clinical guidance on climate issues, including extreme heat and pollution. A reactor panel, including a specialty society and a patient, will explore opportunities for medical societies to protect patient health in a changing climate.

Shifting the Society Focus: Engaging and Retaining Gen Y & Z

There are both challenges and opportunities in shifting society strategic plans to interest and engage younger members, with the goal of active and ongoing participation in society membership and activities. This cross-cutting panel will explore these shifts, examine lessons we can learn from physician training programs and even other industries, and provide resources so that societies can remain relevant and robust in the coming years.

Innovation in Clinical Registries

With rapidly changing data infrastructure and use cases, specialty society clinical registries continue to evolve and innovate. The session will provide a historical overview of a longstanding registry and gain a better understanding of the transformation of the registry digital infrastructure. Society registries are increasingly important for research, evidence, quality improvement, and education. Session participants will learn about new use cases and associated business models.

Critical Equity Conversations in Medical Education and Practice

With equity as a strategic priority for specialty societies, this session will offer guidance on how to educate and engage members in equity discussions. Physician leaders from two societies will offer innovative approaches to reshape member education, including interventions to address social drivers of health and use of global health to discuss equity and racism with learners.

Evolving Approaches to Digital Quality Measurement

While the field is moving toward digital measurement, many CMSS members have experienced challenges on the path to digital measures. At this session, you will hear from innovators in the digital measurement space, including NCQA, CDC, and ACEP. The session will explore what the future holds for digital measures and the broader measurement data ecosystem, including clinical registries.

Building AI into Medical Education

Join us for an in-depth exploration of AI in medical education and contribute to a forward-thinking dialogue on its responsible and impactful application.

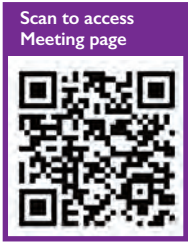
