  - Expert Panel applications will be considered based on the following criteria:
    - Relevant Long COVID clinical management and expertise: Primary care, including Internal medicine, family medicine, pediatrics, nurse practitioner; cardiovascular, neurology, musculoskeletal, pulmonary, occupational medicine, physical therapy, and rehabilitation

- Experience with development and dissemination of educational resources and learning collaboratives for clinicians
- Lived experience
- **January 13, 2025** or earlier – Candidate Notification
- **January 2025** – Initial Expert Panel Meeting (virtual)
- **February 2025**– Expert Panel Meeting (hybrid)
- **Ongoing** – Additional virtual meetings, as needed.
